

# LUTRON MINIMUM ADVERTISED PRICE POLICY FOR THE UNITED STATES OF AMERICA AND CANADA

Prices effective July 1, 2024

Applicable territory: United States and Canada

## PURPOSE

Lutron Electronics Co., Inc., and Lutron Electronics Canada, Inc., (collectively, “Lutron”) is committed to serving our customers by providing products of the highest quality, performance, and value. In order to successfully achieve this goal, we rely on our authorized retailers, distributors, dealers, and other sellers (collectively, “Sellers”) in the United States and Canada to add value to our products before they reach their final users. This value takes the form of place utility, product stocking, consultative selling, system design, and customer support. To promote our Sellers’ ability to effectively provide these services, and to preserve the value of our products and the integrity of the Lutron brands, we are implementing this unilateral Minimum Advertised Price Policy (the “Policy”), which applies to all authorized Sellers of our products selling to end-user consumers in the United States of America and Canada.

This Policy is effective July 1, 2024 and supersedes all of our prior policies or representations regarding minimum advertised prices or minimum resale prices for the Covered Products (as defined below) applicable to Sellers. Lutron will maintain a currently effective copy of this Policy at [lutron.com/salespolicies](https://lutron.com/salespolicies) for your reference.

## COVERED PRODUCTS

This Policy applies to advertisements of our products listed on the Lutron MAP Schedule (“Covered Products”), the current version of which is available at [lutron.com/salespolicies](https://lutron.com/salespolicies). The MAP Schedule will be made available to all Sellers and may be changed by us at any time at our discretion. Sellers are responsible for reviewing the current MAP Schedule, but we will work to promptly notify Sellers when any updates are made.

## THE MINIMUM ADVERTISED PRICE

The Minimum Advertised Price (“MAP”) is the lowest price at which the Covered Product may be advertised. We are solely responsible for (1) establishing the MAP for each Covered Product and (2) communicating this Policy to all Sellers (including via directing any distributors to pass down a copy of this Policy to their reselling customers). **While Sellers remain free to advertise and sell all of our products (including the Covered Product) at any price, it is a violation of this Policy for a Seller to advertise any Covered Product at a price lower than the MAP.**

# LUTRON MINIMUM ADVERTISED PRICE POLICY FOR THE UNITED STATES OF AMERICA AND CANADA

## ADVERTISING AND ADVERTISEMENTS

For purposes of this Policy, the terms “advertising” and “advertisement” include all promotional or pricing information of Covered Products displayed in any type of media, including, but not limited to:

- newspapers
- catalogs
- magazines
- flyers
- brochures
- television
- radio ads
- billboards
- outdoor signage
- websites
- blogs
- social media
- affiliate marketing networks/ comparison shopping engines
- seller-initiated text messages or emails to customers or prospective customers
- mobile/smart phone applications
- banner ads
- online product ads
- paid search ads
- pay-per-click ads
- display ads
- mobile ads
- product listing ads
- sponsored links
- ads in any other media in a digital format that is conveyed via the Internet
- any other marketing or promotional materials, whether displayed online, through broadcast, or other media

The terms “advertise” and “advertisement” do not include:

- Signage displayed within a brick-and-mortar selling location; and
- Pricing information displayed at the Final Online Checkout Stage (which is the stage of a transaction when the Covered Product is put into a shopping cart that contains the customer’s name, shipping address, email address, and payment information). Please note that pricing information in the “shopping cart” or the Final Online Checkout Stage must be obscured technically so that it is not retrievable by shopping and pricing engines and not displayed on search page results within the Seller’s own website.

## POLICY VIOLATIONS

Advertisements that violate this Policy include, but are not limited to:

- A. Offering coupons, discounts, rebates, or other inducements that, when applied, result in an advertised price lower than the MAP, including through use of a storewide sale, department-wide sale, category-wide sale, website-wide sale, promotional code, or other similar provision that can be applied to the Covered Products
- B. Bundling Covered Product with other products or services (whether made by or provided by Lutron or another entity) in a manner that implies below-MAP pricing for the bundled Covered Product, provided however, that it shall not be a violation of this Policy if such bundled products are listed as a bundle on the MAP Schedule, and separate prices for such bundles are not calculated out in the advertised price for the products in the bundle
- C. Strikeouts or strikethroughs of advertised pricing information, “click to see price,” “see price in cart,” “click for lower price,” “mouse over for price,” “check cart for lower price,” or other statements that suggest a lower price for a Covered Product may be found at the Final Online Checkout Stage
- D. Permitting any third party to alter the advertised price for any Covered Product

# LUTRON MINIMUM ADVERTISED PRICE POLICY FOR THE UNITED STATES OF AMERICA AND CANADA

E. Direct or indirect attempts to circumvent this Policy

Notwithstanding the prohibitions set forth above, it is not a violation to advertise the following:

- F. Customer-Initiated Solicitations for Price: That a customer may “call for price,” “text for price,” or “email for price,” as long as no price is listed and no automated call, text message, or “bounce-back” email is used in response
- G. Free/Reduced Price Shipping: A free or reduced-price shipping advertisement as long as such offer applies to all, or almost all, other products offered by the Seller in the same product category
- H. Loyalty Points: the accrual and application of “points” or other things of value (“Loyalty Points”) in connection with the purchase of a Covered Product, provided that (1) Loyalty Points may be accrued and applied to all, or almost all, of the products offered by a Seller and (2) the rate of accruing Loyalty Points for Covered Products is no more than the rate applicable to all or almost all other brands of products offered by the Seller

## THIS POLICY IS NOT AN AGREEMENT AND IS NON-NEGOTIABLE

This Policy is not an agreement between Lutron and any other entity. We do not seek, and will not accept, any promise of compliance with this Policy from any Seller or other party, and each Seller must independently choose whether to comply with this Policy. **This Policy is not negotiable and will not be altered for any individual Seller.**

## MAP HOLIDAYS

We may announce MAP holidays or promotions that are applicable to all Sellers, during which periods a Seller that advertises a Covered Product in compliance with the terms of the MAP holiday will not be considered to have violated this Policy.

## NONCOMPLIANCE

We will take actions against any Seller that does not comply with this Policy, which may include a notice or warning of the violation, a period in which we stop shipment and/or cancel any pending shipments to you and do not accept any orders from you, or a termination of our business relationship and a revocation of your “authorized” status. We have sole discretion to enforce this Policy without notice. Sellers have no right to enforce this Policy.

Although we are not directing any Seller to require that its customers comply with this Policy, a violation of this Policy by any such third party will constitute a violation by the Seller.

## POLICY ADMINISTRATION

We may update, revise, suspend, or otherwise modify this Policy at any time at our discretion, and any modifications will be made available to all Sellers.

Please note that our employees or agents cannot modify, interpret, or grant any exceptions to this Policy; cannot solicit or obtain the agreement of any person or entity to comply with this Policy; and cannot otherwise discuss any aspect of this Policy with any Seller, including that Seller's, or any other Seller's, compliance with the terms of this Policy.
